## HRADF declares the pre-qualified investment schemes

## for the tenders of Egnatia Odos motorways and Alimos marina

The Board of Directors of the Hellenic Republic Asset Development Fund (HRADF), during today's meeting, pre-selected the investment schemes which meet the criteria to participate in the second phase of the tenders for the granting of the right to use and exploit the Egnatia Odos motorway and the marina of Alimos.

Following the evaluation of the Expressions of Interests by its advisors, HRADF's BoD decided that seven investment schemes are prequalified to participate in phase B' of the tender for the **Egnatia Odos motorway** (in alphabetical order):

- 1. ANAS International Enterprise S.p.A.
- 2. DIOLKOS S.A
- 3. GEK TERNA S.A. EGIS PROJECTS S.A.
- 4. FREYJA HOLDINGS SARL [Macquarie European Infrastructure Fund 5 L.P. / Macquarie European Infrastructure Fund 5 SCSp]
- 5. ROADIS Transportation Holding S.L.U. AKTOR CONCESSIONS S.A.
- 6. SICHUAN COMMUNICATIONS INVESTMENT GROUP CO., LTD DAMCO ENERGY S.A.
- 7. VINCI HIGHWAYS S.A.S VINCI CONCESSIONS S.A.S MYTILINEOS HOLDINGS S.A.

## Alimos marina

Following the evaluation of the Expression of Interest by its advisors, HRADF's BoD decided that for the next phase of the Alimos marina tender, eight investment schemes meet the eligibility criteria (in alphabetical order):

- 1. AKTOR CONCESSIOS SA and TEK TEK ART KALAMIS VE FENERBAHCE MARMARA TURIZM TELESISLERI A.S
- 2. ATESE SA (ENGINEERING COMMERCIAL CONSULTING SOCIETE ANONYME PRIVATE SECURITY SERVICES COMPANY)
- 3. AVIAREPS- COSMOS CONSORTIOUM



- 4. INTRAKAT SA
- 5. LAMDA DOGUS MARINA INVESTMENTS SA
- 6. KASOS SA
- 7. PORT ADHOC SAS- DREAM YACHT METITERRANEE J&P AVAX S.A
- 8. PORTO CARRAS SA

Following signing of the relevant confidentiality agreement, the prequalified investment schemes for each tender will receive the documents of phase B' (submission of Binding Offers) and will be granted access to the virtual data room (VDR), where data and information related to the assets and the tenders will be uploaded.

Finally, the BoD of HRADF declared the tender for the exploitation of the marina of Pylos incomplete, as no investment scheme submitted a binding offer.
