1st Amendment of the Invitation to Submit an Expression of Interest

The Invitation to submit an Expression of Interest for the Concession of Port Operation Services and of the right to use, operate, manage and exploit the Marina of Kalamaria dated 22.01.2021 (the "Invitation"), is amended in accordance with this document.

1. Amendment of paragraph 3.2 ("Phase A – Pre-Qualification")

The second section of paragraph 3.2 of the Invitation, is amended, replaced and valid as follows:

- *«Candidates, either natural persons or legal persons or groups of such persons (consortia, joint ventures etc.) shall express their interest by submitting a written Eoi. The Eoi should be submitted on **Wednesday, July 14, 2021** (the "**Submission Date**") to the Fund's premises as specified in Section 6.2. Groups of natural or legal persons, consortia and joint ventures*

are referred to hereinafter as “Consortia” or a “Consortium”. Each member of a Consortium is referred to hereinafter as a “Consortium Member”. Natural persons, legal persons and Consortia, participating in the Tender Process, are referred to in this Invitation as the “Interested Parties”, and each as an “Interested Party”.»

2. Invitation in force

- 2.1. Subject to the above amendments, the Invitation dated 22.01.2021, as amended, remains in full force as for the whole terms and conditions included therein.
- 2.2. HRADF reserves its right for eventual further amendments of the terms of the Invitation, which might be considered as expedient or necessary, at HRADF’s absolute and free discretion.
