According to clause 4.3.2.4 ii) of the RfP, if the Interested Party is unable to provide the means of proof mentioned in clause 4.3.2.4 i) for the Economic and financial standing, at the stage of the Tender Process, (indicatively, in case the publication of said documents is not required under the applicable law of the country in which the economic operator is established), the financial capacity shall be proven by way of any other equivalent documentation, which, according to the national law of the country in which the Interested Party is established, can confirm the respective criterion.</p>
